 - a. Renewal Fee: Most domains are US\$30.00 (renewal + processing fee)
 - i. You can email support@directnic.com to confirm the fee before you send payment.
 - b. You may incur additional fees depending on your payment method
3. Fill in your payment information on the form
4. Sign the form
5. Fax the form to directNIC at **+1.888.564.7373** or scan and email to accounting@directnic.com
6. Send an email to accounting@directnic.com with the following information:
