Terms and Conditions

The Current Registrant and the New Registrant agree to be bound by this Internet Domain Transfer Agreement ("Agreement"), which shall take effect when the last required signature is provided.

WHEREAS the Current Registrant and directNIC have entered into a Terms of Service Agreement at <http://www.directnic.com/legal/> (the "TOS") for the registration of the domain name(s) referenced in the space above entitled Domain Name (the "Domain Name");

WHEREAS the New Registrant desires to register the Domain Name with directNIC and to that end has already or will open a directNIC account to hold the Domain Name, thereby consenting to the TOS;

WHEREFORE, in consideration of these promises, and for other good and valuable consideration the sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Current Registrant's Relinquishment of the Domain Name: The Current Registrant hereby relinquishes its rights in the registration/ownership of the Domain Name and discharges directNIC from all obligations under the TOS. The Current Registrant releases directNIC from all claims, liabilities or demands arising from this Agreement and the TOS. The Current Registrant further acknowledges and agrees that it is not entitled to a refund of any fees it may have paid to directNIC. Nothing contained in this Agreement shall be construed as an assignment of the Current Registrant's rights under the Agreement. The Current Registrant hereby authorizes directNIC to take all steps necessary to register the Domain Name for the New Registrant, including without limitation, disassociating the Domain Name from the host servers designated by the Current Registrant without further notice.

2. New Registrant's Registration of the Domain Name: The New Registrant acknowledges that it has reviewed, understands and consents to the TOS. The New Registrant, by signing and sending this Agreement to directNIC, agrees to be bound by and to perform in accordance with the TOS, incorporated full herein by reference. The New Registrant specifically agrees to pay directNIC a new registration fee prior to registration of the Domain Name for the New Registrant. The New Registrant also reaffirms the accuracy and completeness of all of the information contained in the Agreement and its directNIC account(s). To the extent any part of the TOS conflicts with this Agreement, the terms and conditions of this Agreement shall prevail.

3. Effective Date of the New Registrant's Registration of the Domain Name: The New Registrant's registration of the Domain Name shall be effective upon directNIC's transmission of an acknowledgement to the New Registrant that the Domain Name has been transferred to the New Registrant or upon directNIC's receipt of full payment of fees from the New Registrant, whichever occurs later.
